Agreement effective 7-15-2023

All dogs must be current with their vaccinations at the signing of this contract. All ribbons and trophies will be returned to each owner. As is customary, all cash prizes and promotions shall become the property of the handler, up to \$250.00. All entries are to be charged to the owner's credit card at _____ entry service. If Dog is entered and not shown due to inconvenience or personal reasons, owner will be billed for the normal amount for show and board. In all cases, should a ring conflict arise, we will make every effort to have a qualified handler show your dog. Fees are charged accordingly. All client Dogs that reside with handler have priority over part-time Dogs. It is expressly understood that it is the client's responsibility to advise the handler of any habits the Dog may have that could possibly present a problem in giving safe and adequate care in the handler's facility, while traveling to shows or at the show site. It is also the client's responsibility to furnish medications and written instructions for medications of any kind. It is understood that the owner of the Dog will assume all costs by the handler for any medical treatment by a veterinarian required for the Dog while under the supervision of the handler. It is further agreed that the handler shall determine the need for any veterinary care while the animal is under his/her supervision. The owners of Dogs shown by us will be responsible for a portion of our travel expenses, to be prorated equally among each Dog. Expenses will include gas, road help, tolls, motel, meals, parking, grooming space (when necessary), etc. All bills are due upon receipt and prior to the release of any Dogs. Bills that are thirty (30) days past due are subject to a 2% charge on the unpaid balance. Dogs will not be released to a third party without the expressed consent in writing by the owner.

It is agreed that all disputed bills will be settled in the Courts of Washington County, New York.
